1 PRESIDENT CORDEIRO: Good morning.

2 If you haven't already, can I invite you to please

3 take your seats.

4 (Whereupon, a video was played.)

5 PRESIDENT CORDEIRO: On that note,

6 good morning, everyone. Welcome to Scottsdale.

7 Welcome to our Annual General Meeting. As

8 President of U.S. Soccer, I hereby call our

9 National Council Meeting to order. It's wonderful

10 to see you all. So many friends, colleagues and

11 partners. We come from every corner of our

12 country, from every kind of community, but we're

13 all here for the same reason. We all love this

14 game and we all want to make soccer in America the

15 very best it can be.

16 So on behalf of all of us at

17 U.S. Soccer, let me express our appreciation,

18 firstly, to everyone here at The McCormick Ranch

19 Resort for their hospitality and thank you as well

20 to all our local members, our youth, the Arizona

21 Soccer Association, and our adults, the Arizona

22 State Soccer Association. It was great to see so

23 many of you --

24 (Applause.)

25 PRESIDENT CORDEIRO: And we have

1 sunshine today. It was great to see so many of

2 you at your council meetings yesterday and hope

3 you all had a good time at last night's welcome

4 event, but not too good of a time, I hope. We

5 have a full schedule today, including tonight's

6 dinner, when we'll present our highest honor, the

7 Werner Fricker Builder Award, to the one, the only

8 April Heinrichs.

9 (Applause.)

10 PRESIDENT CORDEIRO: We have a lot

11 on our agenda this morning. So I want to get

12 right to it.

13 Here at U.S. Soccer we're not

14 just a Federation, we're a family, and when a

15 member of our family succeeds, we're united in our

16 pride for them and when we lose a member of our

17 family, we're united in our grief.

18 Could I ask you to please stand

19 for a Moment of Silence as we remember and honor

20 the friends and members of our soccer family who

21 left us this past year.

22 (Whereupon, a Moment of Silence

23 was had.)

24 PRESIDENT CORDEIRO: Thank you,

25 everyone. Please take your seats. The friends we

1 lost this year knew that soccer truly brings us  
 2 together as communities, as a country, as a  
 3 country that has been defended by patriots and  
 4 this includes military veterans on our U.S.  
 5 Paralympic Team such as Gavin Sibayan.  
 6 Growing up in Colorado, Gavin  
 7 loved sports, including soccer. He enlisted in  
 8 the U.S. Army, attained the rank of staff sergeant  
 9 and deployed to Iraq. During a one-month period,  
 10 his convoy was hit by explosive devices on three  
 11 separate occasions. He is the recipient of two  
 12 Purple Hearts. Later returning home, he suffered  
 13 two strokes and lost feeling on his right side.  
 14 But he said "I couldn't let anything hold me  
 15 back."  
 16 He started competing with our  
 17 Paralympic Soccer Team. He represented the United  
 18 States at two Paralympics and here at the Federation  
 19 Gavin serves on the Athletes' Council. Gavin has  
 20 worn the uniform and fought for our nation. He has  
 21 worn the crest and played for our nation and we're  
 22 deeply honored this morning that Gavin is with us  
 23 today. I'm going to ask you to please join me in  
 24 welcoming and thanking Gavin and stand as he  
 25 leads us in the Pledge of Allegiance.

1 (Whereupon, the Pledge of  
 2 Allegiance was recited.)  
 3 PRESIDENT CORDEIRO: Thank you,  
 4 Gavin, for your service to our nation and, at this  
 5 point, can I invite Bob Kepner, chair of our  
 6 Credentials Committee, to come up and conduct the  
 7 roll call, provide the Credentials Committee  
 8 Report for today's meeting. Bob?  
 9 MR. KEPNER: I'll be right there. I  
 10 took my little detour because I wanted to say  
 11 hello to Cindy Parlow Cone who is originally from  
 12 Tennessee, but now she is a North Carolinian and  
 13 she is a favorite to all of ours. So she is  
 14 outstanding and I just wanted to say hello. So  
 15 welcome to Arizona, Cindy.  
 16 MS. PARLOW CONE: Thank you.  
 17 MR. KEPNER: It gives me enormous  
 18 pleasure -- boy, this is a hard to see place in  
 19 here, isn't it, Carlos? It's always a pleasure to  
 20 stand before you and to welcome you and also to  
 21 explain how this all goes about. Those of us who  
 22 have been around for a long time remember before  
 23 we had these little keypads and song we had cards  
 24 and everything. Lots of the folks in this room  
 25 remember that.

1 For a number of years, we've had  
 2 a special way of balancing the votes. Carlos  
 3 emphasized that we're a family and that's the  
 4 essential element of our system for voting. We  
 5 want every member of the United States Soccer  
 6 Federation family to be a legitimate whole part of  
 7 that family and that's the basis for the voting  
 8 system that we have.  
 9 So we'll go ahead and explain it  
 10 and I'll start out with a statement that we know  
 11 we have four different councils; the Youth, the  
 12 Adult, the Pro and the Athletes. The three first  
 13 ones; the Youth, the Adult and the Pro, they are  
 14 equally weighted. This is not new information to  
 15 you, but I always do remember that sometimes we  
 16 have some brand new people to our gathering here.  
 17 So I'd like to explain the little details of how  
 18 we do it.  
 19 We go on the basis of using the  
 20 largest of those three groups and that's the  
 21 Youth. In this case, you'll find out that there  
 22 are 301 votes. That's not necessarily the number  
 23 of people, but 301 votes, and then using magical  
 24 mathematics we equate the Adult Council vote to  
 25 equal that and the Pro Council vote to equal that.

1 And then we add some of the other persons, the  
 2 other members, and together -- we add all of those  
 3 together and then balance out so that the  
 4 Athletes' vote is effectively at least 20 percent  
 5 of the total vote.  
 6 So I'll give you the details. I  
 7 believe you showed the first slide that that was  
 8 the Youth Council already and I presume the Adult  
 9 Council was shown. Let me just run through the  
 10 numbers. Looking out with the lights it's a  
 11 little difficult. Okay. The Youth Council you  
 12 can see 301 votes. We've listed all of the state  
 13 associations, affiliate organizations and the  
 14 commissioners total of 301. So mathematically the  
 15 three councils; Youth, Adult and Pro must equal  
 16 that. So we'll move onto the Adult.  
 17 Same effective system here and  
 18 we take 193 and we're going to have to use some  
 19 magical mathematics to make 193 equal to 301 and  
 20 we'll do that in a moment. So we'll move onto the  
 21 Pro's. And I want to say that I'm very pleased  
 22 with the attendance of the Pro's this time. This  
 23 is the largest number of delegates that we've ever  
 24 had and so I want to applaud them personally.  
 25

1 (Applause.)  
 2 MR. KEPNER: Being part of the  
 3 family and being part of the process is absolutely  
 4 critical. We'll move on to the others, the next  
 5 slide, and you see that we have the Athletes'  
 6 Council, 11 here. And that's close to the number  
 7 that we had last year. That was the record that  
 8 we had. That's very important. We'll move on to  
 9 the next slide.  
 10 And the other affiliates and you  
 11 see national associations and such, other members  
 12 total 14. Well represented. We'll move on. And  
 13 then we have the Life Members, a critical part of  
 14 our -- our membership. These are folks who have  
 15 done all of the things through the years to keep  
 16 us -- get us started and keep us going. So we  
 17 appreciate their continuing to attend.  
 18 Next slide, the Board of  
 19 Directors and the past Presidents. This, of  
 20 course, is the first time we've had three persons  
 21 listed in that past presidents category. So Bob  
 22 Contiguglia, Dr. Bob; Alan and Sunil now is the  
 23 newest person. Sunil also does sit on the Board  
 24 of Directors, but, you see, each person can only  
 25 have one -- vote for one entity and so Sunil,

1 although sitting on the Board of Directors,  
 2 also -- only votes as a past president.  
 3 Okay. Next slide. And then I  
 4 talked about the fact that we have a multiplier  
 5 situation. So you can see on the far left all of  
 6 those numbers added up. Those added up to 558 and  
 7 then we have to equate the Adult Council and the  
 8 Pro Council to equal the Youth Council and then  
 9 the Athletes' Council. We add the 301 times 3 is  
 10 903, plus 36 is 939 and then 20 percent of the  
 11 total mathematically of the 1,181 is 242. So this  
 12 is our system, the multipliers, and these are  
 13 already in your individual keypads and we spent  
 14 time last night putting them out there on the  
 15 tables at your spots.  
 16 So the Youth Council obviously  
 17 one, Adult Council you can see -- I won't go  
 18 through them individually, but each time we vote  
 19 this is the way it works. So thank you for that.  
 20 I do want to say a couple of  
 21 things here. Practice is very important in life.  
 22 We do that in soccer all the time. I know. And  
 23 you have keypads in front of you that look very  
 24 complicated. If I can borrow yours, yes, it's a  
 25 horribly complicated item, but it has power. So

1 I'd like you to pick it up and we're going to  
 2 practice the use of this complicated device and we  
 3 have a special question that we want to ask you  
 4 and if we go ahead and display that question.  
 5 First, I'll explain. Voting is  
 6 live when the question appears on the screen. For  
 7 bylaws, you'll select 1 for yes and 2 for no. You  
 8 can change your vote until voting stops and the  
 9 way we do it is I'll signal it by saying "Vote  
 10 now" or "Stop voting now" and it counts down 5, 4,  
 11 3, 2, 1 and then it stops at that point. You have  
 12 to have voted already. So you can see it's --  
 13 it's a very important thing.  
 14 Let's go to the next slide. So  
 15 here's your practice question.  
 16 Have you ever attended a FIFA  
 17 Women's World Cup?  
 18 Push 1 for yes and 2 for no.  
 19 Okay. Vote now. 5, 4, 3, 2, 1.  
 20 Let's see what the results are.  
 21 And that's excellent 43.2 percent say "Yes" and  
 22 56.8 percent say "No."  
 23 Now, as I looked around the  
 24 room, though, as you were doing that, I saw some  
 25 nervousness about how to use these devices. And

1 let me tell you a story. Last night -- you know,  
 2 the Credentials Committee spends hours getting  
 3 ready for these events and practically spend the  
 4 whole night and I was out in the desert last night  
 5 after we finished up in here and low and behold  
 6 unbelievably two animals walked up to me.  
 7 I said "What are you doing?"  
 8 "Well, I happen to be the state mammal" and you  
 9 can see the cat on the side. There, number one,  
 10 is the ring-tailed cat. That's the state mammal  
 11 of Arizona. The friendly little fella on the  
 12 right, number two, is a ridge-nosed rattlesnake  
 13 and those two fellows slithered and walked up to  
 14 me and I said "What are you doing?" "Well, we're  
 15 out here playing soccer" and I said "Okay. Are  
 16 you any good at it?" "Oh, absolutely. Very good"  
 17 and the cat said "When it comes to a soccer ball,  
 18 I'm the best around." So he certainly knew the  
 19 shape of the ball.  
 20 And the snake, the rattlesnake,  
 21 said "I'm the -- hiss -- I'm the best there is."  
 22 So I'm going to ask you now to vote to see who --  
 23 which of the two would win a penalty kick  
 24 shootout, the ring-tailed cat or the ridge-nosed  
 25 rattlesnake. Push 1 for the cat and 2 for the

1 rattlesnake.  
 2 Okay. 5, 4, 3, 2, 1. Let's see  
 3 the result. Oh, my gosh the cat did it. You know  
 4 what the snake said? "I tried my best to rattle  
 5 you, but it just didn't work." The cat responded  
 6 "I'm feline fine."  
 7 Thank you very much to the  
 8 members of the staff who have gotten all of this  
 9 together; Caitlin Carducci, Greg Fike, Lydia  
 10 Wahlke, Pinky Raina and Lynn Frazier and the  
 11 members of the committee; Siri Mullinix, Kathy  
 12 Zolad, Dimitrios Efstathiou and Tony Falcone. You  
 13 have done a superlative job in getting this all  
 14 done.  
 15 I will now ask for a motion to  
 16 accept the Credentials Report.  
 17 AUDIENCE MEMBER: Move it.  
 18 AUDIENCE MEMBER: Second.  
 19 MR. KEPNER: I hear a motion. I  
 20 hear a second. All those in favor, please say  
 21 "Aye."  
 22 MULTIPLE SPEAKERS: Aye.  
 23 MR. KEPNER: Opposed, please say  
 24 "No." The motion carries. Thank you very much.  
 25 Have a nice meeting.

1 (Applause.)  
 2 PRESIDENT CORDEIRO: Okay. On that  
 3 note, thank you, Bob. Thank you to the entire  
 4 Credentials Committee. You did great work. Let's  
 5 move on.  
 6 Everyone should have received  
 7 the transcript of our meeting last year in  
 8 Orlando. The meetings -- the transcript was  
 9 approved by the board as draft minutes and has  
 10 been published on the U.S. Soccer website.  
 11 If there are no further  
 12 corrections, the minutes will stand as approved.  
 13 All right. Thank you.  
 14 Moving on, today we can all take  
 15 pride that soccer in America is more popular than  
 16 ever with more players, more coaches, more  
 17 referees, more fans than ever before and for this  
 18 we can thank countless leaders who have devoted so  
 19 much of their lives to this sport and to our  
 20 Federation, especially our distinguished Life  
 21 Members.  
 22 We're honored to be joined by  
 23 some of them today and if I can name them out;  
 24 Gianfranco Borroni, Dr. Bob Contiguglia, Mike  
 25 Edwards, Burt Haimes, Gerhard Mengel, Francisco

1 Marcos and Hank Steinbrecher. Welcome. Please  
 2 stand up.  
 3 (Applause.)  
 4 PRESIDENT CORDEIRO: Thank you.  
 5 Thank you. I'd also like to acknowledge and thank  
 6 our past presidents. I don't think Alan is here  
 7 today. I haven't seen him this morning. But, of  
 8 course, Dr. Bob and Sunil Gulati to my right.  
 9 We're also very, very pleased to be joined by a  
 10 number of special guests and please join me in  
 11 welcoming, and I'd ask you to stand as I call you,  
 12 the president of Canada Soccer, a great partner,  
 13 friend of ours in our united 2026 bid to bring  
 14 back the Cup to North America Steve Reed.  
 15 (Applause.)  
 16 PRESIDENT CORDEIRO: From UEFA, over  
 17 in Switzerland, head of National Teams competition  
 18 Lance Kelly.  
 19 (Applause.)  
 20 PRESIDENT CORDEIRO: And from FIFA,  
 21 the Regional Development Manager of the Americas,  
 22 Jose Rodriguez and Director of Member Associations  
 23 of the Americas Jair Bertoni.  
 24 (Applause.)  
 25 PRESIDENT CORDEIRO: And if I might

1 add, Jose and Jair, we thank FIFA for its  
 2 continuing support of all of its member  
 3 associations, including our own, particularly with  
 4 programs like FIFA Forward. We're very, very  
 5 grateful to you. Thank you.  
 6 (Applause.)  
 7 PRESIDENT CORDEIRO: And another  
 8 critical player in our 2026 bid, in fact, he was  
 9 instrumental in winning support, strong support,  
 10 unanimous support, from CONCACAF for our bid. We  
 11 could not have won without them, CONCACAF  
 12 President Victor Montagliani.  
 13 (Applause.)  
 14 PRESIDENT CORDEIRO: I'm delighted  
 15 that Victor will share a few words with us later  
 16 this morning.  
 17 On that note, let me turn to the  
 18 Presidents Report. A year ago, you gave me the  
 19 incredible honor of serving as president and, once  
 20 again, from the bottom of my heart, I thank you  
 21 for this great, enormous privilege. It's been  
 22 deeply humbling and I'm grateful to so many of  
 23 you. We are, after all, a Federation. We're only  
 24 as strong as our members and our ability to work  
 25 together as one united team.

1           So to all of you who have  
2 offered your talents and your time, I can't thank  
3 you enough. When I spoke to you last year, we all  
4 agreed that U.S. Soccer needed to change and I  
5 promised to focus on four main priorities to make  
6 soccer in America the very best it can be.

7           Look, we still have a lot more  
8 to do, but the past 12 months, I believe, has been  
9 a year of progress and change in these four areas.  
10 First, we had to win our bid to co-host the Men's  
11 World Cup in 2026. Our joint bid with Canada and  
12 Mexico was the first ever three country bid. So  
13 we came together and worked together as equal  
14 partners in friendship and in mutual respect. It  
15 was also the first time that all member  
16 associations of FIFA had a vote in that decision.

17           The question of who would host  
18 in '26 often, often became mixed with global  
19 politics. There were moments when some thought we  
20 might not win. So we put together a plan that  
21 highlighted not only our world class stadiums and  
22 cities, but also our values, our diversity and how  
23 our countries welcome people from all over the  
24 world. We waged a global campaign, we worked hard  
25 for every vote and it paid off. We won by an

1 overwhelming margin and for the first time ever --  
2 sorry -- for the first time in more than 30 years  
3 the Men's World Cup will come back to America. As  
4 I've said before, and I'll say it again, this will  
5 be an extraordinary opportunity to energize soccer  
6 in America and not just in '26, but in the years  
7 leading up to it.

8           Second priority, we agreed last  
9 year that our governance had to be more open, more  
10 accountable, more inclusive with more oversight  
11 and so it's been a year of reform. I made a point  
12 to communicate with all of you regularly so that  
13 you know what's happening at the Federation and  
14 why. We created two new committees, a Technical  
15 Development Committee and a Commercial Committee  
16 so that the board now plays a greater role in all  
17 Federation activities.

18           All six of our board committees  
19 are now under new leadership. Meanwhile, at  
20 Soccer House, we restructured our senior  
21 management to align with the board and improve  
22 that accountability. In fact, I'm pleased that  
23 we've now named nine of our ten senior managers  
24 who report to the CEO and we're moving ahead with  
25 our search for the first ever general manager for

Page 20

1 our Women's National Team.

2           We formulized and expanded our  
3 membership department so that we're listening to  
4 and serving all of our members better. All 12  
5 standing committees, task forces and panels have  
6 more new members than ever before, new voices and  
7 new perspectives from across the Federation.

8           We've strengthened our commitment to diversity,  
9 equality and inclusion, including appointing our  
10 first ever Chief Talent and Inclusion Officer Tonya  
11 Wallach. And, today, we'll elect a new  
12 Independent Director and a new Vice President to  
13 help us sustain and build on these reforms.

14           So as we move forward, I hope we  
15 can also deal honestly with an issue that has come  
16 up over the years time after time again, the fees.  
17 The fees that you the members, including youth and  
18 adults, pay to the Federation. When you raise  
19 these concerns, we take them seriously. So we  
20 opened the books, we dug into the numbers because  
21 it's important that we all know and have the  
22 facts. And what we found is that over the years  
23 the Federation consistently gives back to our  
24 collective membership more than what it pays us in  
25 fees.

1           This is -- this includes, for  
2 example, grants to members from our Innovate to  
3 Grow Fund. However, this doesn't include the many  
4 noncash contributions and support that members  
5 receive from the Federation. More importantly,  
6 going forward, and that's where I hope we can  
7 focus, our overall relationship and how we work  
8 together to strengthen it and that's more  
9 important to me than who pays what to whom.

10           Of course, growing the game  
11 requires something else, growing our budget. And  
12 as you'll hear today, we propose to draw on our  
13 surplus so that we can increase our spending  
14 budget for this new fiscal year by 18 percent to  
15 more than \$136 million. This will be our largest  
16 increase in several years and our largest budget  
17 ever allowing us to increase our investments  
18 across the board.

19           With that said, to truly compete  
20 with world class programs like Germany, England,  
21 France, Spain and others in Europe which have  
22 budgets that are much, much larger than ours, we  
23 still need to do dramatically better. I'm pleased  
24 that with the new major multiyear sponsorships, we  
25 are on our way, but we have a long way to go.

1 I want to share one further  
 2 thought on the relationship between the Federation  
 3 and its members. As you know, the Federation has  
 4 unfortunately been subject to lawsuits from within  
 5 our soccer family. Defending each suit consumes  
 6 significant time, energy, resources and obviously  
 7 including legal fees and I want to take this  
 8 opportunity to say to everyone you have my  
 9 commitment as President, the commitment of this  
 10 board, to being your partner and it is my sincere  
 11 hope that instead of rushing to the courts when  
 12 there is a disagreement we can work together  
 13 through our differences amicably. Instead of  
 14 paying huge, massive legal fees to lawyers, let's  
 15 invest that money where it really belongs, in our  
 16 players, coaches, referees helping our teams  
 17 achieve their highest potential.

18 This relates to my third  
 19 priority, truly investing in our National Teams.  
 20 We're making sure that from now on soccer  
 21 operations are run by soccer experts. On the  
 22 men's side, I know that change hasn't come always  
 23 as quickly as some would have wanted to, but  
 24 between doing it fast and doing it right, we have  
 25 been determined to do this right and we are. And

1 we're thrilled, thrilled to have hired our first  
 2 ever general manager for the mens three-time World  
 3 Cup veteran Earnie Stewart. Earnie --  
 4 (Applause.)

5 PRESIDENT CORDEIRO: Earnie led our  
 6 search for a new head coach, the first U.S. World  
 7 Cup veteran to become head coach of the team,  
 8 Gregg Berhalter, who is here with us this morning.  
 9 (Applause.)

10 PRESIDENT CORDEIRO: Gregg, I warn  
 11 you. We're all soccer experts in this room.  
 12 You're going to get a lot of free advice this  
 13 morning.

14 We're delighted that  
 15 both of you could join us this morning, but with  
 16 the rising -- a rising crop of young, talented  
 17 players, the new culture, Gregg, that you're  
 18 introducing into the squad, we believe our men are  
 19 poised for a new era and what does that mean?  
 20 Most importantly, defending this year their title  
 21 at the CONCACAF Gold Cup. Best of luck.

22 And what an amazing year it was  
 23 for our Women's National Team, a historic fifth --  
 24 500th win, an undefeated 2018, winning the  
 25 SheBelieves Cup and the Tournament of Nations and

1 their sixth CONCACAF Championship.  
 2 Congratulations to Jill Ellis and our  
 3 extraordinary women, the #1 women's team in the  
 4 world.  
 5 (Applause.)

6 PRESIDENT CORDEIRO: Jill couldn't  
 7 be with us this morning. They're in Tampa.  
 8 They're just beginning camp, but as they're  
 9 starting camp as they prepare for the next  
 10 SheBelieves Cup, I want to encourage everyone here  
 11 to get out, support our women as they get ready to  
 12 defend their title at this year's World Cup in  
 13 France and bring that trophy home again.

14 But we can't rest on our  
 15 laurels. We have to consistently review our  
 16 programs and push ourselves to get better. The  
 17 truth is our U-20, our U-17 women had another  
 18 difficult year. Looking ahead, the competition on  
 19 the women's side is only going to get more  
 20 intense. Around the world, more nations are  
 21 investing heavily in women's soccer.

22 In fact, at the UEFA Congress  
 23 last week, which I was at, they announced a  
 24 four-year strategic plan to take women's football to  
 25 a new level. Now, all of that means that we have

1 to do even more to sustain the competitive edge of  
 2 our women's programs here in the United States and  
 3 that is why today I'm announcing a new strategic  
 4 review of women's soccer. We're going to pull  
 5 together a team of experts from inside and outside  
 6 the Federation and I'm going to propose that it be  
 7 led jointly by our next Vice President as well as  
 8 our future General Manager of the Women's National  
 9 Team.

10 We're going to review all levels  
 11 from the youngest grassroots programs to the  
 12 senior women's team and we're going to undertake a  
 13 complete inventory of what we're doing today with  
 14 the goal of determining what more we can be doing  
 15 and where we can be investing more tomorrow  
 16 because we need to ensure excellence across all  
 17 our women's teams.

18 So when we look ahead to 2027,  
 19 we can imagine, dare I say dream, of once again  
 20 hosting the Women's World Cup right here in the  
 21 United States including a win on home soil.

22 Beyond our National Teams, we  
 23 honor every athlete who wears the crest. This  
 24 year we'll be cheering our Paralympians in the  
 25 world championship in Spain and the Parapan

1 American Games in Peru. And the best of luck,  
 2 too, to our Beach National Team as they aim to  
 3 qualify for the Beach Soccer World Cup.  
 4 I'm pleased to announce that  
 5 starting this year for the first time ever we will  
 6 have a new department at U.S. Soccer focused  
 7 exclusively on supporting our extended National  
 8 Teams; the Paralympians, Beach and Futsal with the  
 9 dedicated budget starting this year at \$2 million.  
 10 Strong teams also depend, of course, on a strong  
 11 and passionate fan base.  
 12 Today, we're once again joined  
 13 by members of our Fan Council who I would ask to  
 14 stand and be recognized. I'm sorry. I'm not sure  
 15 where you are. There they are.  
 16 (Applause.)  
 17 PRESIDENT CORDEIRO: Thank you for  
 18 your commitment and we're delighted, of course,  
 19 that so many fans, including younger fans today,  
 20 come out to support, especially our women, and  
 21 we're always committed to improving that fan  
 22 experience. We'll soon be releasing a brand new  
 23 website and an app for fans later this year and  
 24 we're working with the council -- in conjunction  
 25 with the council.

1 World class games also depend on  
 2 world class referees. Our American referees are  
 3 some of the most respected in the world. In fact,  
 4 there were four American referees selected for the  
 5 Men's World Cup in Russia, more than any other  
 6 country. On VAR, the United States, including  
 7 Major League Soccer -- or I should say because of  
 8 Major League Soccer is also a global leader. At a  
 9 FIFA summit last month in Morocco, we made the  
 10 case that VAR should be part of this year's

 24 new USL Championship, to the thriving Major League  
 25 Soccer on track for 28 teams and if anyone doubts

1 the strength and future of soccer in America, they  
 2 need only look at the most recent MLS Cup. It was  
 3 the largest crowd ever. The future is, indeed,  
 4 soccer. Congratulations, Don.  
 5 (Applause.)  
 6 PRESIDENT CORDEIRO: So how do we  
 7 build on this energy and excitement in the years  
 8 ahead? This brings me to my fourth -- or our  
 9 fourth and final priority. Growing the grassroots.

 13 adult members boost participation and as I hope

 24 again, encourage every eligible member to come to  
 25 us with your ideas, actual plans, programs, that

 2 Growing the game, might I add,  
 3 also includes attracting more adults and players  
 4 for life. I informed the Adult Council yesterday  
 5 that we agreed with our friends at UEFA to

 8 The photo you're looking at is for this year's  
 9 champions, the Milwaukee Bavarians.

 25 and that is why for the first time ever we've

 25 connect to fans and the start of 2019 has seen us

 2 sponsor. This unique partnership will see us  
 3 connect to fans across the country and extend our  
 4 education and development initiatives through the

 8 referees and fans of the sport. We have also

 25 we focused on diversity with our staff because we

 25 programming to grow the game while looking to

 3 eye on our future which we believe is very bright.  
 4 With that overview, I now would  
 5 like to introduce Richard Moeller, our treasurer,

 9 MR. MOELLER: Thank you, Dan. Good  
 10 morning, everyone, and thank you for the

 12 You have in your AGM advanced  
 13 materials the proposed budget for Fiscal Year  
 14 2020. As this was my first year as the Chair of  
 15 the Budget and Finance Committee, I wanted to give  
 16 you a sense of the process that we go through as a  
 17 committee to create the budget.  
 18 We start with our strategic  
 19 plan, which is driving us towards our mission of  
 20 making soccer the preeminent sport in the United  
 21 States. The Federation is in year two of a  
 22 five-year enhanced investment plan which has us  
 23 operating in a deficit position. This is planned  
 24 through 2022 and is designed to increase our  
 25 performance on and off the field as we look to

1 renew our commercial agreements beyond the 2022  
 2 timeframe.  
 3 This August -- or past August --  
 4 we started a budget process by reviewing the  
 5 five-year framework from the Board of Directors  
 6 discussing the key revenue and expense drivers in  
 7 the context of the framework and then looking more  
 8 closely at Fiscal Year 2020 and the drivers and  
 9 opportunities that we would project. In October  
 10 of last year, we had more granular discussions of  
 11 the Fiscal Year 2020 drivers, opportunities and  
 12 tied that into how we were going to measure  
 13 efforts so we could track our progress.  
 14 With these parameters in place,  
 15 the staff continued to work on creating the  
 16 budget. So you have the committee and the staff  
 17 working on this. This is very -- a very big  
 18 process. Then in November, we had our final  
 19 discussions and review of the Fiscal 2020 budget  
 20 in its entirety, along with how it would fit into  
 21 our five-year investment plan.  
 22 After an in-depth conversation,  
 23 the Budget and Finance Committee voted unanimously  
 24 to recommend approval of the budget to the Board  
 25 of Directors. In December of last year, the board

1 also unanimously approved the Fiscal Year 2020  
 2 budget. With that background, I want to call out  
 3 a few of the highlights of the budget itself.  
 4 Number one, the Women's World  
 5 Cup. This will be our largest investment in  
 6 activation to date around the competition. Number  
 7 two, digital infrastructure. We unveil our new  
 8 digital platforms, both website and an app which  
 9 will connect us with the fans like never before.  
 10 Number three, program development. The continued  
 11 evolution and expansion of our stakeholder area,  
 12 including international relations, referee program  
 13 evolution, licensing, education and evaluation,  
 14 continued evolution of our Youth National Team's  
 15 program and in integration with our player  
 16 development programming.  
 17 Number four was the Men's  
 18 National Team playing in the Gold Cup and the  
 19 inaugural CONCACAF Nations League. And, number  
 20 five, Open Cup improvements. I would also like to  
 21 highlight the funding we receive from FIFA, we're  
 22 very appreciative, as part of its global FIFA  
 23 Forward Program. U.S.A. Soccer applies for  
 24 funding from FIFA as part of its global FIFA  
 25 Forward Program.

1 This program is FIFA's effort to  
 2 support specific individual Federation projects  
 3 that are aligned with FIFA's own strategic  
 4 initiatives. For the three-year period 2016 --  
 5 sorry -- 2016-2018 with the support and guidance  
 6 from FIFA, we have received \$2,250,000 that went  
 7 towards several projects which include the  
 8 following:  
 9 The development of four online  
 10 grassroots coaching courses, that was \$535,000;  
 11 the development of an online grassroots refereeing  
 12 course, that was \$587,500; our first girls academy  
 13 director course, that was \$196,458; the  
 14 development of an academy summer showcase, which  
 15 supported players, coaches, referees,  
 16 high-performance and scouts, \$397,005; the  
 17 development academy winter showcase, which also  
 18 supported players, coaches, referees,  
 19 high-performance and scouts, that was \$515,425.  
 20 So as part of FIFA's Forward  
 21 commitment, we are required to submit to a  
 22 statutory audit which, as you know, we conduct on  
 23 an annual basis as well as a FIFA Forward  
 24 programmatic audit, including multiple impact and  
 25 milestone reports for each project that we do.

1 I'm pleased to report that we received very high  
 2 remarks from FIFA on the programmatic audit and  
 3 are in full compliance with all requirements.  
 4 Moving forward, the staff at  
 5 Soccer House will continue to manage this program  
 6 heading into a new FIFA Forward 2.0 funding period  
 7 for the years 2019 through 2022. We will report  
 8 back to the National Council each year, or as  
 9 necessary, to confirm the status of our FIFA  
 10 Forward funding.  
 11 So, all in all, the budgeted  
 12 deficit for Fiscal Year 2020 is similar to that of  
 13 Fiscal Year 2019. For FY '20, we are budgeting a  
 14 deficit of \$14,263,320, while in Fiscal Year '19,  
 15 we were projecting a deficit of \$13,697,629.  
 16 We're investing for the future.  
 17 Overall, the Federation remains  
 18 in excellent financial shape and will continue to  
 19 be in the future. I wanted to thank the committee  
 20 for their work on the budget. I'd like to make a  
 21 special announcement of some of the members;  
 22 Carlos Bocanegra, Steve Malik, John Motta,  
 23 Dr. Pete Zopfi. I also wanted to thank the staff  
 24 at U.S. Soccer for their work on this process and,  
 25 finally, I wanted to take a minute to introduce

1 our new CFO of U.S. Soccer Pinky Raina. Pinky  
 2 joined us in January and we look forward to

 16 member. They were approved by the Board of  
 17 Directors as a provisional member about a year  
 18 ago. Since that time, they have added a few  
 19 additional leagues in additional states. Unless  
 20 there is an objection, ANFEEU's membership will be  
 21 approved by the general consent. Hearing no  
 22 objection, let's welcome ANFEEU as a member of

24 (Applause.)  
 25 MR. FIKE: The second membership

8 (Applause.)  
 9 MR. FIKE: Last, but not least, the

 15 there is an objection to the Blind Athletes --

20 (Applause.)  
 21 MR. FIKE: I would now ask --  
 22 recognize our Chief Legal Officer Lydia Wahlke to  
 23 present the bylaw amendments. Thank you.

24 (Applause.)  
 25 MS. WAHLKE: Thanks, Greg. Included

Page 48

1 in your Book of Reports in Section 6 are a series  
 2 of bylaw amendments. As required by Bylaw 802,  
 3 all of the proposed amendments have been reviewed  
 4 by the Rules Committee and their reports are  
 5 included in the Book of Reports. We will now  
 6 proceed to consideration of the proposed bylaw  
 7 amendments.

8 There are some changes to the  
 9 set of proposed amendments proposed by the  
 10 Secretary General. The proposed amendments to  
 11 Bylaws 102, 103, 211 and 212 are being withdrawn.  
 12 In regard to the proposed amendment to Bylaw 241  
 13 on pages 14 and 15 of the Secretary General's

 18 Please strike out that bolded language. The  
 19 proposed additional language in bold in Section 3

21 Therefore, as proposed, Bylaw  
 22 241 only includes changes in Section 3. All of  
 23 the amendments proposed by the Secretary General  
 24 are recommended by the board. It is proposed to  
 25 consider all of the amendments proposed by the

 2 consent agenda procedure. These are the proposed

 2 cons. Do we hear a pro for forwarding it to the

 24 wants the participants to have a seat at the  
 25 table, but we want to make sure that if it's

1 somebody that has some other ancillary thing that  
2 is related to soccer comes in isn't necessarily  
3 there.

4 So those are the current  
5 concerns that were raised and since as a practical  
6 matter it's not going to impact the election  
7 before March 18th anyhow, passing it to the Rules  
8 Committee could resolve this where everything  
9 comes forward with a plan that everybody supports  
10 and would pass unanimously next year as the other  
11 bylaws did.

12 So, with that, I personally --  
13 not from what was said in the room yesterday, but  
14 I personally would support sending it for the  
15 greater discussion.

16 MS. BERLING-MANUEL: May I respond  
17 to that at all? Is that appropriate?

18 MS. WAHLKE: We'll get back to you,  
19 Lynn.

20 MS. BERLING-MANUEL: I'm not going  
21 anywhere. It's good.

22 MS. WAHLKE: Of course you're not.  
23 We'll give Chris a moment to respond as the main  
24 proponent and then we'll give Lynn a chance to  
25 respond.

1 MR. AHRENS: Thanks. I want to just  
2 offer some context. John, I would slightly  
3 disagree with you. I don't know that -- my group  
4 does not -- I don't think issues is the right way  
5 to put it and we're certainly not recommending  
6 this so that it goes back to the Rules Committee

18 We are two members of this  
19 association, long-term members. We have the  
20 ability to vote and have done so for the budget

23 have the ability to vote for officers. We have  
24 the ability to nominate board members. We have  
25 the ability to run for this board position.

1 The only ability we do not have  
2 is a single vote for the board position. So we  
3 appreciate the concerns. We have found most --  
4 none of the members we have spoken to have  
5 addressed them and, again, we would ask for this  
6 not to go back to the Rules Committee, but to be  
7 voted on today.

8 Quite frankly, if I were to make  
9 an amendment to the amendment this morning, it

 13 our Federation and our Board of Directors benefit  
 14 from the service and contributions of Independent  
 15 Directors.  
 16           Our Independent Directors are  
 17 selected because they bring unique experience,  
 18 expertise, often from the private sector, to help  
 19 make our Federation even stronger and more  
 20 effective. They are truly independent. They do  
 21 not represent any member of our Federation.  
 22 They're tasked with providing impartial advice and  
 23 counsel. I am very grateful that you gave me the  
 24 opportunity to begin my service here at the  
 25 Federation as an Independent Director.

1 Over the past couple of years,  
2 two years actually, we have benefitted from the  
3 contributions of Val Akerman as an Independent  
4 Director. Val's voice and prospectus has been  
5 greatly appreciated and while Val has decided not  
6 to seek a second term and was unable to join us  
7 today, we wish her the very best and we thank Val  
8 for her valuable contributions to U.S. Soccer.

9 So today we're considering a  
10 candidate to fill this vacancy. At the board  
11 level, our Nominating and Governance Committee,  
12 along with an independent outside firm, conducted  
13 a rigorous search and reviewed and interviewed  
14 numerous candidates. The committee presented its  
15 recommendation to the board which accepted it and  
16 now presents this candidate for your  
17 consideration.

18 Let me first thank John Collins  
19 and the members of the committee for their  
20 commitment and diligence in this process and for  
21 putting forward such a strong candidate Patti  
22 Hart. Patti, who joins us today, has more than 40  
23 years of private sector experience. She is a  
24 highly respected leader in the gaming industry.  
25 She has helped grow and lead major companies and

1 with her experience as a business leader and as a  
2 CEO Patti brings deep expertise in technology,  
3 entertainment and gaming and a passion, I might  
4 add, for sports and soccer all of which make her  
5 an ideal candidate for Independent Director.

6 She will also be our First Chair  
7 of our Commercial Committee. So, with that, all  
8 those in favor of the election of Patti Hart as an  
9 Independent Director, please say "Aye."

10 MULTIPLE SPEAKERS: Aye.

11 PRESIDENT CORDEIRO: Any -- any  
12 opposed? Well, done. Ayes have it.  
13 Congratulations, Patti, and on behalf of all of us  
14 welcome to U.S. Soccer.

15 (Applause.)

16 PRESIDENT CORDEIRO: Last years  
17 presidential election in Orlando also left a  
18 vacancy for Vice President and in accordance with  
19 our bylaws and our policies, the nomination  
20 process for Vice President was public and opened  
21 in November, closed in December. One candidate  
22 completed the nomination process, Cindy Parlow  
23 Cone.

24 I'm not going to spend a lot of  
25 time reciting Cindy's lifetime of experience, we'd

1 be here all day, but as an active member of our  
2 soccer family for more than two decades, many of  
3 you know her well. As a player, she helped lead  
4 our Women's National Team to a World Cup victory  
5 in 1999, to two Olympic gold medals after that and  
6 as a pro she helped pioneer and play in our first  
7 women's professional soccer league, WUSA.

8 As a coach, she has mentored and  
9 developed players at nearly every level, including  
10 the NWSL as the first coach of the Portland Thorns  
11 winning that league's first ever championship  
12 seven years ago. As a member of our Federation,  
13 she has taken on numerous responsibilities,  
14 including as a past member of our board  
15 representing the Athletes' Council.

16 Today, she continues as a  
17 non-voting advisor to our council -- Athletes'  
18 Council and as a co-chair with Dan over our Youth  
19 Task Force and for her life of achievement, we  
20 were thrilled, thrilled this past fall to induct  
21 Cindy to the National Soccer Hall of Fame.

22 Cindy, we're very grateful that  
23 you've submitted your nomination to take on even  
24 more responsibility in helping to lead this  
25 Federation. This election is to fill the

1 remaining one year of the current term for Vice  
2 President. At our AGM next year, there will be  
3 another election for a full four-year term. So  
4 since we have only one candidate for this office,  
5 we're going to conduct this election by voice  
6 vote. All those in favor of the election of Cindy  
7 Parlow Cone as Vice President, please say "Yes" or  
8 "Aye."

9 MULTIPLE SPEAKERS: Aye.

10 PRESIDENT CORDEIRO: The ayes have  
11 it. Everyone, please join me in welcoming our new  
12 Vice President of U.S. Soccer Cindy Parlow Cone.  
13 (Applause.)

14 MS. PARLOW CONE: Thank you. It is  
15 such an honor to stand here today as your Vice  
16 President. Thank you for having the confidence in  
17 me as I step into this new role. I am  
18 passionately driven to positively impact our game  
19 at all levels and across all demographics. And  
20 just so you know, I will lean heavily on you to  
21 help me do that because this is a collaboration  
22 among all of us.

23 My objective as VP is to be an  
24 active and impassioned advocate for all of you who  
25 move and develop our game on a daily basis. I

1 believe that with my extensive knowledge of and  
 2 experience working in the soccer landscape --  
 3 landscape of our country from grassroots to the  
 4 international level, I can help us continue to  
 5 build, develop and grow soccer in the U.S.  
 6 Together we will improve the experiences of  
 7 everyone in our great game. I look forward to  
 8 working with all of you. Thank you.  
 9 (Applause.)  
 10 PRESIDENT CORDEIRO: Thank you.  
 11 Thank you so much, Cindy. With her experience as  
 12 a player, a coach, a leader, a friend to so many  
 13 people across our Federation, I can't imagine a  
 14 better person for this job. Let me just say as  
 15 President and a very personal level, Cindy, how  
 16 grateful I am that you've taken on this role to  
 17 include, as I mentioned earlier, taking --  
 18 agreeing to help lead our new strategic review of  
 19 women's soccer. So we're truly, truly excited to  
 20 have you on board.  
 21 Let me also note a couple other  
 22 changes at the board -- here at the Board of  
 23 Directors. As her term comes to an end, I ask you  
 24 to please join me in thanking Angela Hucles for  
 25 her valued service as an athlete representative on

1 the board and for co-chairing with Carlos  
 2 Bocanegra the Technical Development Committee.  
 3 Thank you, Angela.  
 4 (Applause.)  
 5 PRESIDENT CORDEIRO: And, finally, I  
 6 want to thank John Collins, a longstanding,  
 7 at-large board member who has decided not to seek  
 8 re-election at the end of his term next month. So  
 9 this will be John's last in-person board meeting  
 10 as well. John, we're very grateful to you for  
 11 your wise counsel, for chairing our Nominating and  
 12 Governance Committee. Thank you very much.  
 13 MR. COLLINS: Thank you.  
 14 PRESIDENT CORDEIRO: We began our  
 15 meeting today by saluting our great Life Members  
 16 and I can report that the Board of Directors  
 17 recently approved the nomination of our newest  
 18 Life Member Richard Groff. For more than three  
 19 decades, Richard has strengthened soccer at every  
 20 level. From leading Pennsylvania Youth Soccer and  
 21 U.S. Adult Soccer, the American Professional  
 22 Soccer League, paving the way for MLS, to helping  
 23 build the mens and the womens game, to serving on  
 24 the board of our Federation and the U.S. Soccer  
 25 Foundation.

1 Five years ago, Richard was  
 2 recognized with the Werner Fricker Builder Award  
 3 and today, by acclamation, we are proud to welcome  
 4 Richard Groff as our newest Life Member. Richard,  
 5 please stand up.  
 6 (Applause.)  
 7 PRESIDENT CORDEIRO: You guys have  
 8 been getting up a lot today. We're not done yet.  
 9 Now, before one of our great traditions here at  
 10 U.S. Soccer, For the Good of the Game, before I do  
 11 that, I want to acknowledge all of our past, maybe  
 12 present, National Team players, men and women, who  
 13 are here today be it on the Athletes' Council or  
 14 in any other capacity. Please stand up and be

 17 PRESIDENT CORDEIRO: Before we open  
 18 up the floor for For the Good of the Game, I  
 19 wanted to begin by inviting one of our special

 22 CONCACAF President Victor Montagliani.  
 23 MR. MONTAGLIANI: Thank you, Carlos.  
 24 Gracias. Good morning, everyone. It's nice to  
 25 see spirited debate alive and healthy in -- in our

 20 MR. MONTAGLIANI: I'd also like to  
 21 acknowledge all the councils here and also  
 22 specifically the Athletes' Council who I've had  
 23 the privilege of going -- coming to speak to the  
 24 last few years. I always enjoy being around  
 25 players. I think it's very important that -- and

 23 welcomed them home and, to me, those are signs  
 24 that on that side of the game that this region has  
 25 tremendous potential, not only to win the World

1 Cup, but also to really light the flame of women  
 2 all -- all across our region.  
 3 The U-20 Men's Championship  
 4 congratulation to Tab Ramos. I had the pleasure  
 5 of also being there and it was a tremendous  
 6 tournament at the IMG facility and 2018 was -- was  
 7 a World Cup year and -- a World Cup year, but also  
 8 a watershed moment for this region. A watershed  
 9 moment in this region because as we had started  
 10 off this meeting the winning of the united 2026  
 11 bid and I think as we look to that as our North  
 12 Star over the next seven, eight years I think it's  
 13 important, though, to take into context really  
 14 what, I think, our next challenge is in this  
 15 region.  
 16 And when I say this region, I  
 17 think obviously the U.S. Soccer, which is a key  
 18 color and a major piston in the engine in our  
 19 region that our next frontier is really about  
 20 culture and the culture of futbol. And what is  
 21 the culture of futbol? You know, it's not about  
 22 paying \$200 million for a player. It's not about  
 23 wages at 300,000 -- 450,000 Pounds a week.  
 24 What culture is is what we have  
 25 in this region. For too long, I keep hearing that

1 futbol or soccer is the future in this region.  
 2 Well, it's not the future, ladies and gentlemen,  
 3 it's the present. And I think it's time we start  
 4 speaking with a different candor and a different  
 5 tone starting with our leaders in U.S. Soccer and

 22 November a strategic plan for CONCACAF. We  
 23 launched a process, a process that will take 18  
 24 months, that will culminate at some point in 2020  
 25 and that process will involve all the

 2 present in this room, all the stakeholders in our

 4 And really what that strategic  
 5 plan is it's called CONCACAF 2030 and it is really

 21 Missouri roots. Dan is the very definition of  
 22 Midwestern humility. He doesn't boast, he doesn't  
 23 seek the limelight and as a result the scope of  
 24 his impact is not always fully known on the  
 25 outside. So I want to take this opportunity, if I

1 may, today to briefly share a few highlights and,  
 2 yes, Dan, we're going to embarrass you just a  
 3 little.  
 4 In Dan Flynn -- in Dan Flynn,  
 5 our Federation found the proven experience of a  
 6 player, a business leader and a soccer executive.  
 7 As a star defender in college, he helped St. Louis  
 8 University win the 1973 NCAA Soccer Championship  
 9 and I'm told that back then he also had a pretty  
 10 amazing afro. Wow. In business -- in business,  
 11 he became President of Anheuser-Busch  
 12 International at the age of 31 and in leadership  
 13 positions at U.S. Soccer -- so both at U.S. Soccer  
 14 and at the Foundation, he helped fuel the growth  
 15 of soccer in the late 1990s.  
 16 Today, we see Dan's work as CEO  
 17 in world class facilities from the National  
 18 Training Center in Carson, California, to the  
 19 National Training and Coaching Development Center  
 20 in Kansas City, to the brand new National Soccer  
 21 Hall of Fame in Frisco, Texas. We see his work in  
 22 a renewed focus on National Team and player  
 23 development, especially our youth.  
 24 In fact, during his tenure, our  
 25 Women's National Team won three Olympic gold

1 medals and a World Cup and we see Dan's work and  
2 the critical role in some of our greatest  
3 successes from hosting the 2003 Women's World Cup  
4 with just four months to prepare, to the 2016 Copa  
5 America Centenario, which is a major boost to our  
6 financial security, to our successful bid to host  
7 the Men's World Cup in 2026.

8 I have to point out as many of  
9 you know that Dan did this all in recent years  
10 while undergoing major surgery, a heart  
11 transplant, fully recovering and then getting back  
12 to work often at a relentless pace. Dan is  
13 unstoppable. None of this comes without huge  
14 sacrifice. True, Dan has two great loves in his  
15 life; soccer and his family, but not in that  
16 order. All this time his family has continued to  
17 live back home in St. Louis, Dan has commuted to  
18 Soccer House in Chicago just about every week for  
19 25 years.

20 And next month he and his wife  
21 Cathy, who is with us today, will celebrate their  
22 41st wedding anniversary.

23 (Applause.)

24 PRESIDENT CORDEIRO: On behalf of  
25 all of us, I want to thank Cathy and your

1 daughters, Lauren, Anneliese, and Erin, their  
2 families, and your grandchildren for sharing Dan  
3 with -- with us for all these years. Your legacy,  
4 Dan, will be felt in many other ways. So many --  
5 so many at Soccer House and people in this room  
6 today have their stories. If they asked for five  
7 minutes of Dan's time, he'd give them 30. If they  
8 needed advice, he'd become a mentor.

9 Dan, the example of your  
10 dedication, your decency, will continue to inspire  
11 those who have worked under you the next  
12 generation of soccer leaders for many, many years  
13 to come.

14 So I know I speak for many of us  
15 when I say that it's hard to imagine Soccer House  
16 without you, but you can look back on your tenure  
17 knowing that our Federation and soccer in America  
18 is stronger than ever in no small measure, Dan,  
19 because of you.

20 So as I invite Dan to say a few  
21 words, I will ask you all please to join me in  
22 expressing our profound gratitude to our CEO, our  
23 friend, great champion of soccer in America, Dan  
24 Flynn.  
25

1 (Applause.)

2 MR. FLYNN: Thank you very much.  
3 Thank you. While I kind of pride myself on not  
4 being surprised, but I was very surprised --  
5 Carlos, thank you for that wonderful introduction  
6 and somewhere my wife we're going to have a  
7 discussion about those pictures.

8 As Carlos was providing his  
9 wonderful introduction, I couldn't help but really  
10 stare at Hank. Hank and I are the only two people  
11 who have held this position really in about the  
12 last 30 years and I will never forget the day I  
13 took over and the transition that Hank said to me  
14 "Dan, I will do anything to help you succeed. I  
15 will do anything to help U.S. Soccer succeed."

16 So anybody that knows Hank he is  
17 a man of his word. He was there when the corky  
18 hours when I would call him when maybe things  
19 weren't going so well. I got a lot of calls when  
20 he said "Hey, congratulations." First one to  
21 always call when we had success on the field, but  
22 what I most appreciate about Hank was when he  
23 would call me and kind of say "Hey, Dan, I think  
24 you guys are maybe going off the rails a little  
25 bit." He provided an incredible balance. So,

1 Hank, thank you for your friendship.

2 (Applause.)

3 MR. FLYNN: So I'm frequently asked  
4 over the years what's my favorite team and  
5 obviously it's a trap question and one that I  
6 completely stay away from, but I will now reveal  
7 my favorite team today. It's my medical team.

8 (Applause.)

9 MR. FLYNN: Obviously, without them  
10 I wouldn't be here. But it would be impossible to  
11 thank all of my team members that I work with. I  
12 would be remiss and I'm going to try to just  
13 recognize by name the nine direct reports that I  
14 have, but they epitomize kind of the saying that  
15 it's not about recognition, it's about results.  
16 So Lydia, Jay, Brian, Pinky, Tonya, Neil, Nico,  
17 Asher and Earnie, you make it easy to come in  
18 every day, it's easy to stay motivated and you  
19 continue to motivate me. So thank you very much  
20 for your incredible dedication to U.S. Soccer and  
21 making my job a whole lot easier.

22 (Applause.)

23 MR. FLYNN: As I was thinking  
24 through my transition a number of years ago when  
25 Sunil and I were talking, I was going through my

1 calendar and looking at all the meetings and I did  
2 it for about five, six, seven years and I kept  
3 noticing a certain name that would kind of pop up  
4 on my schedule and then I realized, I said "Heck,  
5 I'm spending more time with Jay Berhalter than my  
6 wife" and so the transition proceeded. Sorry,  
7 Jay, but Cathy's better looking.

8 I do want to -- you always run a  
9 little bit of a risk. I mentioned nine people,  
10 but I do want to mention Jay in particular. He  
11 worked with me at the Foundation and I was able to  
12 get him to come to U.S. Soccer. He did leave U.S.  
13 Soccer for a bit and we were lucky enough to  
14 recruit him back. In any job, there is people  
15 that stay late, give you really good advice, they  
16 give you honest advice, you don't always like to  
17 hear it, but I really couldn't have accomplished,  
18 it's not me, we couldn't have accomplished a lot  
19 of what we've accomplished without Jay. So, Jay,  
20 a special thanks.

21 (Applause.)

22 MR. FLYNN: When Bob Contiguglia and  
23 the board decided to hire me 18.5 years ago, there  
24 were really two things that I thought we could do  
25 as an organization. One was build a brand and the

1 other was to try to find a way to be relevant in  
2 our sport 365 days a year and if we accomplished  
3 both of those items, the financial success would  
4 kind of come along with it and I think we've been  
5 able to accomplish that with the membership in  
6 this room. In terms of building the brand, you  
7 have to thank the athletes. They don the jersey.  
8 They wear the crest. What they do and the success  
9 on the field is so critically important to  
10 building our brand.

11 But when they're playing for the  
12 National Team, they go back, they have to have  
13 somewhere to go back to and they go back to their  
14 clubs and when you look at where we are today  
15 versus 20 years ago, that opportunity that has  
16 been provided by professional soccer and our  
17 country and the growth of us that is really the  
18 reason that we are much more relevant as a sport.

19 So I thank the athletes. I  
20 thank the grassroots at the youth and the adult  
21 level. You bring the joy to the game. For the  
22 youngsters, you provide that platform of joy when  
23 they're adults. And on the relevancy, I just have  
24 to thank professional soccer, all three leagues;  
25 our women's league NWSL, USL and most of all, Don,

1 I want to thank you for your leadership,  
2 incredible growth that you've brought to our sport  
3 and, in particular, and I've said this repeatedly,  
4 I'm not sure they get enough credit for the  
5 supportive culture that now exists in our country.

6 These are fans that they're not  
7 coming to the games. They're donning the scarves,  
8 they're going to the pubs and they're marching to  
9 the games. That's an incredible difference versus  
10 20 years ago and to -- I know our Fan Council is  
11 here -- to the fans who support all the National  
12 Teams, thank you very much.

13 I wanted to take -- be very  
14 brief. I didn't know this was all happening. I'm  
15 kind of scrambling through this a little bit. I  
16 apologize. But I've served under four, but there  
17 have been five presidents that have really  
18 impacted my life. Werner Fricker, the man simply  
19 believed when nobody else did. I was in the beer  
20 business and he asked to arrange a meeting with  
21 the President of Anheuser-Busch who was a big fan.  
22 By the end of that meeting, the President of  
23 Anheuser-Busch was ready to double down, but  
24 Werner believed when very few others didn't  
25 believe.

1 Alan Rothenberg, who is not  
2 here, but staging the World Cup was what everybody  
3 talked about, but he saw it a lot differently. It  
4 was a 30 -- 30-day party and a platform and a  
5 runway to start a Division I men's league. Simply  
6 nothing less than spectacular.

7 Bob Contiguglia, thank you for  
8 hiring me. I would say about the integrity of the  
9 process focus on principles, stay focused on the  
10 important things as to how we get better. We'll  
11 never forget it. He kept it very simple. Very  
12 powerful.

13 Sunil, thank you for your  
14 dedication to the game. Thank you for your  
15 commitment to growth and I will say this of Sunil  
16 that I don't think he has deserve- -- he's gotten  
17 the credit for this particular point. He  
18 absolutely moved us to take risk and that's not an  
19 easy thing to do, move a member organization into  
20 a riskier proposition, but he built that in to the  
21 staff in such a way it became very common. Very  
22 difficult to do, but really needed in the 12-year  
23 run that you had. So thank you very much, Sunil.

24 (Applause.)

25 MR. FLYNN: Carlos, thank you for

1 the kind introduction. I say of Carlos' vision he  
 2 presented a vision, you elected him in '18, led  
 3 the World Cup bid efforts successfully. You heard  
 4 today vision in 2027. That's all balanced with a  
 5 pursuit of excellence. It's a tough balance, but  
 6 one that he handles quite well. So thank you,  
 7 Carlos, for not only today and all the leaders and  
 8 presidents, but thank you for what you're going to  
 9 do for U.S. Soccer in the years to come.

10 So at the end of any journey,  
 11 worthwhile journey, I think you take a moment and  
 12 you kind of go back to your roots and that's  
 13 really what this is about for me, reconnect a  
 14 little bit, grandkids, family, friends that I've  
 15 stayed connected with but haven't had a lot of  
 16 personal contact. So with the grandkids,  
 17 particularly Stella at seven, lives in Overland  
 18 Park, and Danny and Jay in St. Louis, Missouri  
 19 Youth Soccer and Kansas Youth Soccer, ready or  
 20 not, here I come.

21 So I want to -- I talked about  
 22 my favorite team. I'm going to talk about my  
 23 toughest negotiation or conversation I ever had.  
 24 It's really an introduction to my wife but when I  
 25 was going facing surgery, you're encouraged to

1 talk about if you don't make it. It may sound  
 2 kind of awkward today.

3 So I designed this little  
 4 get-together with my wife and I said "Look, if I  
 5 don't make it, I want you to share your life with  
 6 somebody else" and it did not go well. So I tried  
 7 to add a little humor and I said "Would you let  
 8 him drive my car? Would you let him sleep on the  
 9 same side of the bed?" That was the end of that.  
 10 So it was a little chilly and I said "If I only  
 11 have one more question to ask you, would you let  
 12 me do it and I will never ask you another question  
 13 about this" and she said "Okay. If you promise."  
 14 I said "I promise." So I said "Would you let him  
 15 use my golf clubs?" She said "Don't worry about  
 16 it. He's left-handed."  
 17 (Applause.)

18 MR. FLYNN: So I -- I hope my wife  
 19 is here. I don't see her. And I will end, you  
 20 know, really it's about in tough times adding a  
 21 little bit of humor and smiling and a little bit  
 22 of collaboration I think goes a long way. So I  
 23 have everything to thank my wife about for  
 24 allowing me to do this job all these years and I  
 25 will say publicly what I say to my wife every

1 morning I love the way you love me.  
 2 So it's been an honor for 18.5  
 3 years. It's been a privilege. Carlos, thank you  
 4 for your kind introduction. I'm very grateful.  
 5 Thank you.

6 (Applause.)

7 PRESIDENT CORDEIRO: Tough act to  
 8 follow. All right. Now, For the Good of the  
 9 Game. We are, after all, a membership  
 10 organization and this is another opportunity to  
 11 make sure we're always hearing from you, our  
 12 members. This is your Federation. We want to  
 13 hear what's on your mind, your successes, your  
 14 concerns, your ideas.

15 I'd ask, please, that you give  
 16 your name and organization. Keep your comments as  
 17 brief as possible so that everyone has an  
 18 opportunity to speak.

19 With that, the floor is open and  
 20 I'll take -- is that Greg?

21 MR. GRIFFITH: Hi. Greg Griffith,  
 22 Georgia State Soccer Association. I just wanted  
 23 to recognize what happened in Georgia this year  
 24 through Atlanta United and a great leader with  
 25 Carlos Bocanegra up on the stage. In case you

1 missed it, they won the MLS Cup this year, but  
 2 they set single season attendance records of  
 3 averaging 53,000. They had over 900,000 people  
 4 come over 17 home games, set single season records  
 5 for games with around 72,000 attending multiple  
 6 games. We broke a record for MLS All Star Game  
 7 attendance. We broke a record for MLS Cup  
 8 attendance and the environment is just fantastic  
 9 that they've created.

10 If you get a chance, it's sold  
 11 out all the time, but if you get a chance and you  
 12 want to scalp a ticket, come on down, but I just  
 13 want to say thank you to Atlanta United for that  
 14 because ever since I got into the soccer business  
 15 when I tell them what I do almost second or third  
 16 question they say is "When is soccer going to make  
 17 it big in this country" and now thanks to Atlanta  
 18 United if you go to a game, we're here. We made  
 19 it big. So thank you very much.  
 20 (Applause.)

21 PRESIDENT CORDEIRO: Thank you,  
 22 Greg. Tom Moore?

23 MR. MOORE: Tom Moore, California  
 24 Soccer Association North. Thank you very much to  
 25 everyone for passing this new Policy 414-1 today

1 and certainly it will mean a bit more work for the  
 2 national Board of Directors, certainly a bit more  
 3 work for the staff, but it's also an opportunity  
 4 for all of us because as I look across the  
 5 National Council here, I'm quite certain we have  
 6 experts in financial management, IT, human  
 7 resources, education, I would guess that perhaps  
 8 we have a few experts in marketing and PR over on  
 9 the Pro Council. Lord knows we have enough  
 10 attorneys in the room.

11 So please take advantage of this  
 12 opportunity because we're -- we've taken an  
 13 important step towards open governance and your  
 14 expertise can be useful in moving the game forward  
 15 for all of us. Secondly, 30 minutes after this  
 16 meeting ends a group of men and women from the  
 17 Adult Council will be meeting out in the small  
 18 field for some pickup soccer and if I remembered  
 19 my goalkeepers gloves I would throw them down on  
 20 the ground because we are challenging the  
 21 Athletes' Council to a game.

22 (Applause.)

23 PRESIDENT CORDEIRO: Great.

24 MR. KELSEY: Rick Kelsey, Arizona  
 25 Soccer Association. Just two things I want to

1 encourage everybody to become a part of. Here in  
 2 Arizona we've launched a partnership with Clemson  
 3 University. This weekend we're actually hosting  
 4 ten disabled veterans from Arizona. We're putting  
 5 them through the grassroots coaching license and  
 6 it's a program we want to continue to do. I would  
 7 encourage other states to reach out to Clemson  
 8 University as they have a program that they have  
 9 launched this year.

10 Also, we have a club here in  
 11 Arizona, North Phoenix Christian Soccer Club, that  
 12 has 134 refugees. They actually came this week  
 13 and helped U.S. Soccer stuff the goodie bags that  
 14 you guys had. It was an absolutely amazing  
 15 experience for me because as we were here we went  
 16 around and took the kids around the hotel. One of  
 17 the kids said "Wow. I feel rich." I was like,  
 18 well, that's kind of funny. Then we continued to  
 19 walk around. We went by the pool. One of the  
 20 window shades was open. One of the kids looked  
 21 into the hotel room and said "Oh, look. That's a  
 22 really cool bed. I wish I had a bed."

23 These kids are in all of our  
 24 communities. I encourage you to find them, bring  
 25 them together. You have really, really good

1 people, good organizations. When we look at the  
 2 pay to play models we all hear about, these are  
 3 the kids we want to grab, these are the kids we  
 4 want to help and it's a great opportunity. What  
 5 we have also done this weekend is we've taken  
 6 those kids in that club and they're the players

8 So we're integrating these two  
 9 communities together and I encourage all of you to  
 10 reach out to those two communities. Thank you.

11 (Applause.)

12 MR. BORTS: David Borts, Rhode  
 13 Island Soccer Association. First, just to double  
 14 down on all of the congratulations to Dan Flynn.  
 15 He has been a model to us all and a great leader  
 16 of this organization for a long time, for  
 17 everybody here.

18 Second, the reason that I got  
 19 up. In the spirit of one nation, one team and the  
 20 building of this sport, I have to speak with a  
 21 small degree of disappointment today. I found it  
 22 disappointing that bylaw proposals which were  
 23 submitted to this body well in advance and  
 24 unfortunately only considered annually, we were  
 25 not able to support our Armed Services Board's

1 Council request. A number of people in this room  
 2 are disappointed by our action today and I think  
 3 we have to do better. That is a body in this  
 4 country that is clearly part of one nation and one  
 5 team. Thank you.

6 (Applause.)

7 PRESIDENT CORDEIRO: Chris?

8 MR. BRANSCOME: Chris Branscome,  
 9 Eastern Pennsylvania. And on behalf of our state,  
 10 I just want to congratulate our friend and mentor  
 11 Richard Groff on his selection as a Life Member.  
 12 He's done so much for our area, our country, me  
 13 personally. Thanks, boss. You've done a great  
 14 job.

15 And to future Life Member Dan  
 16 Flynn, thank you for what you've done. I guess I  
 17 just nominated you. I also just wanted to say  
 18 Philadelphia welcomes everybody to the SheBelieves  
 19 Cup on February 27th and, CONCACAF, we look  
 20 forward to hosting Gold Cup games later in June.  
 21 So tickets are available. Buy now. Thank you.

22 (Applause.)

23 PRESIDENT CORDEIRO: Thank you.

24 MS. MALONE: Hi. I'm Jessica Malone  
 25 speaking on behalf of the Fan Council. This is

1 our second AGM that we've attended and we wanted  
2 to take time to thank all the regional councils  
3 and all the members who have let us stop by their  
4 meetings and get to meet you guys and learn about  
5 the important work that you're doing because  
6 that's something that sometimes the fans aren't as  
7 aware of as they should be.

8 We want to thank everyone at  
9 U.S. Soccer who always takes the time to show us  
10 what goes on in the day-to-day operations.  
11 Carlos, Jay and Dan, thank you. And also to say  
12 congratulations to Cindy Parlow Cone. We look  
13 forward to working with you over the next year and  
14 to all of you, we hope to see you around at some  
15 games. Thanks.

16 (Applause.)

17 MR. LARABA: David Laraba, West, by  
18 God, Virginia. You knew that was coming. I just  
19 had to do it. A couple quick things. Jennifer,  
20 lieutenant colonel, thank you for coming back this  
21 year and thank you for proudly wearing your  
22 uniform. Well done, Marine. Thank you for your  
23 service to our game and to our country.

24 (Applause.)

25 MR. LARABA: On a personal note and

1 also from West Virginia, Dan, thank you for your  
2 support and all you've done both for West Virginia  
3 and for the game. And my good, longtime, I'm not  
4 going to say how many years, friend, Richard,  
5 congratulations. Well done. Finally, I was  
6 happening to be looking through because a couple  
7 people mentioned, you know, you said something  
8 last year through Good of the Game. Well, that's  
9 a surprise. And I looked to see what I said. I  
10 thought I remembered, but I wasn't sure.

11 So I said because of the crowd  
12 from last year and all of the attendance that I  
13 challenged everybody that was attending to come  
14 back. How many of you were here last year at the  
15 AGM? Can you raise your hand or stand up. Thank  
16 you.

17 The second thing I said was I  
18 challenged the candidates to not walk away if they  
19 weren't -- if -- for ones that were not  
20 successful. I asked them to continue their  
21 service and several of them said they would. I  
22 would like all the candidates who ran for  
23 president last year to please stand up. Thank  
24 you, Carlos.

PRESIDENT CORDEIRO: Thanks.

MR. STEINBRECHER: I might get a bit  
emotional. Hank Steinbrecher, Life Member.  
Danny, everyone knows we shared the same seat.  
They don't know the depth of the friendship that  
we've had. You've taken that chair to new, new  
heights. Today, I pay homage to everything you've  
done for our sport and for the friendship that  
I've had for you over these many years. My only  
prayer is that God continues to bless you. Thank  
you for being such a dear friend and a dear friend  
to our game. Good bless you.

(Applause.)

PRESIDENT CORDEIRO: Sorry. Curt?

MR. REGRUIT: Curt Regruit, New York  
West Youth Soccer. Several years ago when I  
became state president, I -- as I attended  
national meetings, purposely started to reach out  
to various members from the Federation; Caitlin,  
Brian, I knew Carlos, Sunil, Dan and my intent was  
to try and advocate for more commitment to the  
youth soccer game. I had a lot of doubters as I  
talked to people. Many said -- you know,  
questioned whether I would -- I would have much

success, but there are others out there like me  
over the last few years who have done the same.  
It's very clear two years later, three years later  
in your stated commitment that fixing youth soccer  
is a priority that you've listened to us and I  
just wanted to express our gratitude on behalf of  
all of us in the youth soccer game for listening,  
for making that commitment. We'll continue to  
press you, but we're grateful for the commitment  
and we look forward to that commitment going  
forward and the results of it. Thank you.

(Applause.)

PRESIDENT CORDEIRO: Thank you,  
Curt.

MR. POPP: Thank you. Dan Popp from  
Washington Youth Soccer. I just wanted to take a  
moment to -- on behalf of Terry Fisher, our CEO,  
Felipe Mendez, our board Vice President and myself  
to thank the Innovate to Grow Committee and the  
organization for including Washington and our --  
our grant bid to be approved. There is a lot of  
growth happening in our country and your  
investment in those projects is paramount.

As I sit as one of many  
committee members on the Organizational Growth

1 Committee with Dr. Zopfi and the leadership from  
2 Bill Taylor from Idaho, we are working hard to  
3 define ways in which we bring new kids into the  
4 game to engage communities that are not being  
5 engaged with today and the Innovate to Grow grant  
6 that we received and were approved for will be a

16 invest in. So I encourage you all to submit in  
17 the next round. So thank you very much. We  
18 appreciate it.

19 (Applause.)

20 PRESIDENT CORDEIRO: Thank you, Dan.

21 MR. GROFF: Richard Groff and I'm  
22 honored to say Life Member.

23 (Applause.)

24 MR. GROFF: It's a great honor to  
25 join the incredible people sitting to our left and

1 to thank each of you for voting me in. I was a  
2 little nervous there for a while. This was  
3 been -- it has been a 30-year journey and  
4 certainly I need to thank my friends at Eastern  
5 Pennsylvania Youth Soccer and Region 1 that  
6 started this journey, but I wouldn't be here today  
7 without the partners, the mentors, the advisors.  
8 Sunil, Kevin, Hank, especially Dan, you've been  
9 remarkable in your guidance to keep me going. I  
10 love this organization, I love our teams and I  
11 look forward to helping you grow this sport.  
12 Thank you.

13 (Applause.)

14 PRESIDENT CORDEIRO: Lynn?

15 MS. BERLING-MANUEL: I'm not  
16 actually going to say -- speak about the things  
17 that you probably think I'm going to speak about.  
18 I'm just saying. This is actually a moment that I  
19 want to speak to Dan and I am never ever, ever  
20 going to call you Danny just so you know. Ever.

21 Dan and I first met at the then  
22 NSCAA convention a lot of years ago in Atlanta  
23 where he was pouring beer for Budweiser and since  
24 that time -- it's more years than either of us  
25 would probably care to admit to.

1 MR. FLYNN: You're right.

2 MS. BERLING-MANUEL: The hair was  
3 cut by then. I must admit I have never seen that  
4 before. And I just want to say thank you also.  
5 You have been a good friend and a good mentor and  
6 one of the things that I've always appreciated is  
7 that we've been on the same side of the table  
8 occasionally, we've been on opposite sides of the  
9 table, you've been a tad salty from time to time,  
10 but always direct and honest and you've always  
11 said yes when you meant yes and no when you said  
12 no -- when you meant no and that has meant the

6 MS. BENDER: Mary Jane Bender,  
7 Illinois Soccer. Looking back, I met Dan in -- 26  
8 years ago in 1993 when he was the head of the  
9 Chicago World Cup Committee and he has always been  
10 honest with me. He told me things I sometimes  
11 didn't want to hear. I have tremendous respect  
12 for Dan. He's been supportive, a motivator and,  
13 Dan, I just -- it's really sad for me to see you  
14 leave this position because I have a tremendous  
15 amount of respect for you and many of you know  
16 that I'm outspoken and I have ideas and -- but,  
17 Dan, I have such tremendous respect. You were  
18 very important to me and to the state associations  
19 and I wish you the best.

20 MR. FLYNN: Thank you.

21 (Applause.)

22 MR. BOLLINGER: Jim Bollinger,  
23 Eastern Pennsylvania Soccer Association. Three  
24 items. First of all, Dan, I'd like to say thank  
25 you on behalf of the Eastern Pennsylvania Soccer

1 Association family and membership for all your  
 2 years of service and dedication. I was pleased to  
 3 see you actually had a worse hairdo than I did at  
 4 that age in life, although obviously we flipped  
 5 the coin with regards to your hairdo versus mine

 8 you for all your years of service and dedication  
 9 and I am happy to see Richard Groff, one of the

21           (Appause.)

22           MS. HALTERMAN: Kendra Halterman  
 23 from Utah. I also help in the WPSL. For all of  
 24 you that were unaware, Jerry Zanelli passed away,  
 25 the founder of the WPSL, in November. Jerry was a

1 huge advocate of the women's game and he will be  
 2 greatly missed. The WPSL has been taken over by  
 3 three new owners. They are revamping the league  
 4 and making it stronger than ever and I encourage  
 5 all of you to continue to support women's soccer.

6           (Appause.)

7           MR. BERNARD: Good afternoon. Peter  
 8 Bernard from Eastern New York and I'm going to  
 9 make this short and sweet. On behalf of one of  
 10 the oldest states that is part of this  
 11 organization, that started this organization,  
 12 Eastern New York, I want to say thank you to two  
 13 legends, and I mean this sincerely, that is Dan  
 14 Flynn and Richard Groff. So thank you, thank you  
 15 very much.

16           (Appause.)

17           MR. FISHER: Terry Fisher from  
 18 Washington. In 1973 and 1974, UCLA, where I was  
 19 coaching, where Ziggy Schmidt was a player, we  
 20 lost the final in '73 and the semifinal in '74 to  
 21 Dan Flynn and St. Louis University. We also -- we  
 22 also this year lost Ziggy Schmidt and I wanted to  
 23 take a minute to acknowledge Ziggy as a  
 24 personality, as a player, as a passionate soccer  
 25 person and it sort of crosses both areas. We lost

1 a great coach. MLS was nice enough to name their  
 2 Coach of the Year Award after Ziggy and I just

4           (Appause.)

5           PRESIDENT CORDEIRO: One more  
 6 comment.

 8 Missouri Youth Soccer. To Carlos and Dan, Carlos,  
 9 good luck in trying to find a replacement for Dan.  
 10 Dan, you made the offer. Missouri Youth Soccer  
 11 accepts your offer when you're off the board and I  
 12 would like to end with "Go Mix."

13           (Appause.)

14           PRESIDENT CORDEIRO: Thank you.  
 15 Thank you very much, everyone, for those comments.  
 16 I think today --

17           MR. MOTTA: Carlos?

18           PRESIDENT CORDEIRO: I'm sorry. The  
 19 board. Down at that end. John.

20           MR. MOTTA: Yeah, I would like to  
 21 thank Carlos, Jay, Brian, Dan, and, of course,  
 22 UEFA for giving U.S. Adult Soccer an opportunity  
 23 to play at a newer level. We're looking forward  
 24 to partnering with UEFA in this new cup we will be  
 25 playing in 2020. I'd also like to ask our

 20 respect to our region in the world. So thanks for  
 21 coming.

22           I'd like to also congratulate  
 23 Cindy for her new role and, Gregg, for your new  
 24 role and I think it's important to sort of point  
 25 out that as our sport continues to develop and

1 evolve and as Bob mentioned the largest group of  
 2 Pro Council members here representing the women's  
 3 league, Major League Soccer, the USL, the vast

 20 and, Dan, I want to take a couple of minutes, if I  
 21 can, and I promise I won't take too long, to give  
 22 my respect, my admiration and support for  
 23 everything that you've done to lead this  
 24 Federation for so many years. You have such an  
 25 incredible commitment to trying to be as good as

1 you possibly can be in bringing out the best in  
 2 everyone whether it's your staff or it's all those  
 3 people that you've worked with.  
 4         I have been in this job for 20  
 5 years and 19 of those years you've been there to  
 6 help me be the leader that I can be and I would  
 7 not be the person I am, leader of this league, if  
 8 not for you. Major League Soccer would not be the  
 9 league that it is if not for you and that time  
 10 we've spent together both having laughs and having  
 11 our time to try to figure out what we need to do

 2         (Applause.)  
 3         MR. FLYNN: Thank you.  
 4         PRESIDENT CORDEIRO: Sunil?  
 5         MR. GULATI: So to touch on the two  
 6 people that we've talked a lot about today, and  
 7 there are some direct links between them in some  
 8 of the things that both of them have said,  
 9 Richard, who many of you know, some of you don't,  
 10 is actually a big part of the reason that we've  
 11 got a commercial program starting in the late '80s

 9 Dan is familiar with and I was part of and it was

 24 I've ever heard a little bit of a quiver and he  
 25 was calling me from the airport with his wife and

1 said "I'm going to get on a flight and I'm going  
 2 to have a heart transplant."  
 3 Okay. This had come up in that  
 4 previous discussion, which wasn't the centerpiece  
 5 of the discussion, but it was several years away  
 6 when there was a good fit and a transplant  
 7 opportunity and so on eventually. So how this  
 8 happened 48 hours later while we were in the  
 9 middle of this was the only time I've ever heard  
 10 any fear. Not hesitation. We all have that, but  
 11 any fear. For the other 25 to 30 years that I've  
 12 known Dan, there has been none of that.  
 13 The organization is where it is  
 14 in so many ways, in so many places financially, on  
 15 the field, organizationally, in the world and done  
 16 it very quietly as several people has mentioned  
 17 without looking for accolades and then I go to the  
 18 other end of that spectrum today and Dan's words  
 19 which were extraordinary in so many ways and some  
 20 of you have heard one end of Dan's temper along  
 21 the way and today you heard absolutely the other  
 22 end of it which he doesn't share very often but  
 23 had a chance to today.  
 24 And the thing that most  
 25 impressed me was not the humor, which was terrific

1 of course, but there was no fear in any of it and  
 2 leaving a position after such a long time and  
 3 having a career in the sport and he is going to  
 4 continue that sport, it's clear to me and in some  
 5 conversation we've had today and now that he's had  
 6 with all of you that there is a lot more looking  
 7 forward to what he's going to be able to do and  
 8 continue with his family and not any fear about  
 9 what he's going to miss and he'll miss part of it.  
 10 So, Dan, certainly from the  
 11 bottom of my heart and on behalf of this sport and  
 12 everyone that adores you and loves you, thank you  
 13 for everything you've done. No fear going forward  
 14 and I'm sure we're all going to remain friends for  
 15 a very long time. Thank you.  
 16 (Applause.)  
 17 PRESIDENT CORDEIRO: Chris?  
 18 MR. AHRENS: Thanks, Carlos. Dan,  
 19 I'm not always great off the cuff. So I hope this  
 20 comes off as genuine, as I mean it, from the  
 21 athlete perspective. You know, as athletes, you,  
 22 and the organization as a whole, they put the  
 23 utmost faith in us that we would perform on the  
 24 field and win or lose the support was always  
 25 there. And it has to work in conjunction with the

1 business and we look at the organization today and  
 2 we talk about -- we always talk about the numbers  
 3 and the budget and we're positioned better than we  
 4 have ever been and that's all because of you, Dan.  
 5 So while you put your faith in  
 6 us on the field, we had our faith in you in  
 7 leading the mission and the organization and we're  
 8 internally grateful for that. So thank you.  
 9 PRESIDENT CORDEIRO: Okay. I think  
 10 there is nobody else. Let me just say thank you  
 11 again. I think today has been a great reminder  
 12 and over the past year we've made some progress,  
 13 but we still have a lot to do. As members, as

 23 spirit of our work together over the past year,  
 24 our meetings today. I know we will be in the  
 25 spirit of your meetings this afternoon for those

1 of you who have meetings, our dinner tonight, I  
 2 hope everyone will be there and, of course, the  
 3 year ahead.  
 4 So thank you to everyone. A  
 5 special thank you to our dedicated staff at Soccer  
 6 House for all your hard work. The amount of  
 7 detail that goes into organizing these events is  
 8 beyond imaginable, but thank you very much for the  
 9 great success, for this year's AGM. I'm pleased  
 10 to announce that next year our AGM will be held on  
 11 the 13th through the 16th of February in  
 12 Nashville, Tennessee.  
 13 (Applause.)  
 14 PRESIDENT CORDEIRO: And as we  
 15 adjourn and we look to the year ahead, especially  
 16 the Women's World Cup, we have one message to the  
 17 world "Here we come."  
 18 (Whereupon, a video was played.)  
 19 PRESIDENT CORDEIRO: We're done.  
 20 I'll see you tonight at dinner, please. Meeting  
 21 adjourned.
