Jair Marrufo

"Jair has been an instrumental member of the U.S. Soccer FIFA Panel for so many years, and has been a leader for all the other FIFA officials through his example and on-field performances. Jair has represented U.S. Soccer, his family and himself at the highest level of the game including at the 2018 FIFA World Cup in Russia and the 2018 FIFA Club World Cup in UAE, where he was the referee on the Final. We will miss seeing him on the international stage, walking out of the tunnel and taking charge of some of the highest profile matches in the world. SheBelieves Cup 2023

The 2023 SheBelieves Cup, presented by Visa, was held from February 16-22 as Brazil, Canada and Japan join the USA for the four-team international tournament. Part of U.S. Soccer's SheBelieves initiative to inspire and empower women and girls in sport and beyond. The 2023 tournament returned to its traditional three-venue format with matches played at Exploria Stadium in Orlando, Fla., GEODIS Park in Nashville, Tenn. and Toyota Stadium in Frisco, Texas.

Referee Experience Event

United Soccer Coaches, an Associate Member of U.S. Soccer, is continuing to recognize the contributions of soccer officials at all levels beginning with "The Referee Experience" at the 2023 United Soccer Coaches Convention which was held on January 13-14 at the Pennsylvania Convention Center in Philadelphia, PA. United Soccer Coaches (formerly the NSCAA) has long recognized the need to include soccer officials, without whom the organized game cannot be played, into its extended family with the understanding of the importance of sharing common ground information as well as the need to improve communication, cooperation, and camaraderie between Referees and Coaches, who have long suffered from an unfortunate disconnect.

Classroom, field sessions, and social activities with presentations by top instructors from FIFA, US Soccer, CONCACAF, PRO, NCAA, and others highlighted the event. Speakers included Canadian FIFA Instructors Hector Vergara and Michelle Pye, among other experienced officials as well as U.S. Soccer staff and instructors.

2023 National Camp

The 2023 National Camp took place in Chula Vista, San Diego December 3rd-12th. This year's camp certified 106 National Referees and Assistant Referees.

National Match Officials are at the top of the Referee Pathway. Nationals may be assigned top level matches within the country and international friendlies, become a career (full-time, paid) official, and nominated for the United States FIFA Panel, from which World Cup officials may be selected.

At National Camp, the officials attended technical sessions on handball, offsides, PAI (penalty area incidents), challenges, tactical fouls, and game management with top National Instructors:


This year's camp also had a few guest speakers:

Rene Miramontes, U.S. Soccer National Instructor for Coaching Education, presented on the coaching perspective and relationship with officials during matches.

How to Become a National Referee or National Assistant Referee

To become a National Referee or National Assistant Referee, one must meet the eligibility requirements below, complete the annual application in the Learning Center and be selected by the Selection Committee. They must then attend National Camp and satisfactorily complete all technical and physical requirements.

2023 National Referee & National Assistant Referee Eligibility Requirements:

- Age 21 or older
- Must have held a Regional Referee license for the previous 3 registration years.
 - Example: If you are applying for a 2024 National Match Official license, you must have held you held a Regional Referee license in 2023, 2022, and 2021 registration years. Check your Learning Center profile license history to confirm it is up to date and meets these requirements if you are applying.
- Game Count Requirement: 65 games over your career as an official
- Game Assessment Requirement: Three (3) ADULT game assessments completed by three (3) different National Referee Coaches.
- Fitness Test Requirement: Two (2) PASSING regional level fitness tests or higher, with full result details.

For more on the eligibility application requirements, see the application guides of past years and look out for an updated 2024 National Match Officials Application Guide in the Learning Center this summer.

If you are a current regional referee who is eligible for and interested in becoming a National Match Official during the next registration year (2024), we recommend beginning the work to complete your three (3) required game assessments (must be completed by 3 separate National Referee Coaches at an adult game) this Spring.

The U.S. Soccer Referee Department will host a webinar for regional referees interested in applying for the 2024 National Referee or 2024 National Assistant Referee course during the summer. The webinar will review the application process, requirements, and answer any potential questions on the application and certification process. The 2024 National Match Official applications will open at the start of the next registration year (July 2023). More information to come!

What is the United Officials Group?

In August 2021, U.S. Soccer's Referee Department started working with a group of women and minority officials. Many of these officials have not been given the same opportunities afforded to the majority of officials. Referee Continuing Education

Game Management

In this edition, we continue our discussion about 'game management' during the game. Now we present an example under match control - restart procedure (**Figure 1**).



Figure 1. Portion of FIFA Considerations for the topic of Game Management




Figure 2. Example of preventative action for match control – restart procedure

Prior to a free kick near the penalty area or a corner kick, opposing players sometimes charge, push, or hold each other. If this behavior is ignored, then players may intensify such actions prior to the restart of play. Referees, or match officials, must be aware to recognize when this occurs in their games. In addition, referees are encouraged to take preventative action, as appropriate, to avoid escalation (**Figure 2**).

When taking preventative action, ensure that the player taking the kick knows that the game will not restart until the referee signals by blowing the whistle. Identify and approach the player(s) conducting themselves inappropriately. Communicate clearly the behavior that needs to stop or be modified. Take an appropriate position to see prior to the restart. Then, blow the whistle to indicate that the kick can be taken.

We hope that this will help many in their **preparation** and **performance** in their next games. You will be ready for when a similar incident occurs in your game.


